Stay because you have no choice ? Move abroad to live in Another European Country ? Recent Agreements point to British People being able to stay in France if they arrive before Brexit day March 2019. Under this Agreements all UK Nationals legally residing in France by 29 March 2019 will be allowed to stay and enjoy the Same Rights as they do today, including on Healthcare and Pension Uprating.

Among the Three Million European Expats, 300,000 French Nationals represent one of the Largest European Communities in the UK (London is regularly dubbed the "Sixth City of France"). Since the Beginning of the Brexit Campaign, many French Londoners feel estranged in a Country they once considered Home. Now that the UK is running for a Hard Brexit, an Increasing Number are packing up and moving back to France... Meanwhile, France rejoices to see its Expats "" and their Money come home. French Authorities have already started rolling out the Red Carpet for Doubtful Businesses seeking New Headquarters. The French Government is at Full Throttle to attract Businesses, from Big Multinational Banks to Smaller Tech Startups, and French Cities are engaged in a Fierce Competition to attract Sulking Cross-Channel Nationals.
